## **Refund Policies**

### **Tuition and Fees:**

**Payment:** A non-refundable \$350 enrollment deposit is due upon acceptance to the Pre-College Program or Summer College for High School Students to reserve a space in the program AND to secure enrollment in your preferred course. All remaining tuition and fees, including program fee, must be **paid in full by the dates below:** 

Program	Payment Due Date
Pre-College	June 1 *
Summer College Session 1	May 8
Summer College Session 2	June 20

\*If you apply after June 1, your tuition and fees must be paid in full within five business days after notification of enrollment)

Refer to the Bill Pay Instructions to pay the balance on the account.

Financial accounts may be settled online through OPUS or with the Student Account and Billing Office. Parents may view the student account or make payment arrangements through the student's Emory OPUS account. Students who apply and are accepted to the Pre-College Program after May 14, 2023 must submit full payment with admission application.

## WITHDRAWAL/REFUND POLICY

### **Six-Week Credit Courses**

**Withdrawal:** A student may withdraw or change their credit course schedule only with permission and approval from the Director of Summer Programs. Students may withdraw from a credit course and receive a full tuition refund on or before May 16, 2023 (1st session) and July 30, 2023 (2nd session). The enrollment deposit is non-refundable. After the drop/add period (May 16 for 1st session and June 30 for 2nd session) tuition refunds are prorated according to the following schedule.

## **Two-Week Noncredit Courses**

**Noncredit Program Cancellation:** If a student wishes to cancel their program attendance and enrollment, they must notify the Pre-College Program in writing by email: precollege@emory.edu. Students who cancel their attendance prior to June 1, 2023 are eligible for a *tuition refund NOT the \$350 non-refundable enrollment deposit and \$70 non-refundable application fee*. Program fee charges are also not refundable.

All students registered for a noncredit course(s) must attend on or before the second day of class (June 21, July 5, or July 18). Otherwise, enrollment will be cancelled.

Withdrawal: Students may not change noncredit courses or attend another class once the session begins. A student may withdraw from one or more courses only with permission and approval from the Director for Summer Programs. Students who withdraw from the program and/or a noncredit course on or before the second day of class (June 21, July 5, or July 18) will receive a 50% tuition refund less the \$350 non-refundable enrollment deposit. Application fee, enrollment deposit, books, and program fees are non-refundable.

A student who withdraws from the course/program may not continue to participate in program activities or utilize university facilities.
